Accessorial Charges

Transportation

- Fuel surcharge rate is calculated internally and published weekly. Any shipments over 10,000 lbs will be rated at full truck load fuel surcharge.
- Freight shipped on any highway will be subject to a \$2.00 per skid Carbon Tax.
- Freight shipped within city limits will be subject to a \$2.00 per order Carbon Tax.
- FTL detention is charged out at \$85.00 per hour after the 2 hours allotted free time, billed out in ¼ hour increments.
- LTL detention is charged out at \$85.00 per hour in ¼ hour increments, after the allotted free time
 - 1-3 pallets 30 minutes of free time
 - 4-11 pallets 1 hour of free time
 - 11 pallets and up 2 hours of free time
- COD Collection charge is \$13.17 per order
- Attempt Delivery charge for a 3-ton truck is \$26.88 per attempted delivery plus FSC
- Attempt Delivery charge for a tractor/trailer is \$67.25 per attempted delivery plus FSC
- Attempt Delivery charge into Loblaw's Regina is based on the cost incurred
- Loblaw Surcharge freight charges @ 36.68%, maximum charge \$122.26
- Hand bombing (store front delivery) is billed out at \$50.00 per hour, 1 hour minimum
- Tailgate is billed out at \$50.00 per instance.
- FCL TGP sorting charges (1-2 \$26.32)/(3-8 \$52.59)/(9-17 \$81.09)/(18 +skids \$111.51) (27 +skids \$134.90)
- Pratts/ICD Sorting Charges is \$9.30 per pallet
- Swampers are billed out at \$35.00 per hour
- Hot Shot is \$3.55 per running miles plus FSC

- When a customer requests pick up of multiple temperature commodities and will not move existing freight for realignment of temperature zones an additional \$125.00 charge may be applied to cover additional costs incurred.

Warehousing

- Crossdocking rate is \$16.46 per pallet.
- When Aero is required to break down and re-sort pallets on our docks as per specific instructions of either shipper or consignee before delivery to the end customer, a fee of \$25.00 per pallet handling may apply.
- For any calls after regular hours (6am to 5pm Mon to Fri, 6am to 12pm Sat and Sun) there is a \$184.99 dollar call in fee in addition to rates
- Missed appointment without calling prior to re book, there is a \$200.00 per missed appointment.

Administration

- Appointment fee of \$30.00 per appointment may be applied to all orders that require a delivery appointment.
- Pick up cancellations are subject to applicable charges as per costs incurred.
- An administration fee may be applied to non-standard requests.
 - Standard service includes building order, pick-up and delivery, emailed invoice with scanned POD.
- It is the responsibility of the ordering customer to indicate if a shipment is prepaid or collect beyond, without properly confirming this, all shipments will be entered as prepaid and billed to the ordering party.
